#### Mr. WU Hongbo



**Mr. Wu Hongbo** was appointed United Nations Under-Secretary-General for Economic and Social Affairs on 1 August 2012. Prior to his appointment, Mr. Wu served as Ambassador Extraordinary and Plenipotentiary of the People's Republic of China to the Federal Republic of Germany. Among his various diplomatic assignments, Mr. Wu served as China's Ambassador to the Philippines.

Mr. Wu brings to DESA his outstanding policy-making experience and problem-solving skills, as well as rich and extensive experience with multilateral organizations and international conferences. As Director-General and later Assistant Minister of the Ministry of Foreign Affairs of China, Mr. Wu worked with the Chinese inter-agency coordination mechanism for the Boao Forum for Asia, the Chinese working group for the implementation mechanism of the UN conventions on environment and development, and the Chinese inter-ministry coordination mechanism for the World Economic Forum Annual Meeting of the New Champions.

#### H.E. Ahmed Saheer



His Excellency **Mr. Ahmed Sareer** presented his Letters of Credence to His Excellency Secretary General Ban Ki-Moon, as Ambassador / Permanent Representative of the Republic of Maldives to the United Nations on 20 December 2012. He is also concurrently serving as the Ambassador Extraordinary and Plenipotentiary of the Republic of Maldives to the United States of America having presented his Letters of Credence to His Excellency President Barack Obama on 14 January 2013.

From December 2009 until his appointment as Ambassador / Chargé d'Affaires to the Permanent Mission of Maldives to the United Nations in February 2012, Mr. Sareer served as the High Commissioner of Maldives to the People's Republic of Bangladesh. He was Deputy High Commissioner in London, United Kingdom from June 2008 to May 2009, and served as the Charge d'Affaires, Maldives Mission to the European Union, Brussels from March to June 2008. He was the Counsellor and later the Deputy High Commissioner in Colombo, Sri Lanka from July 2006 to March 2008.

In January 2015, the Maldives has assumed Chairmanship of the Alliance of Small Island States (AOSIS), a coalition of 44 small island and coastal nations from around the world, and Mr. Sareer has been leading the process on behalf of the Government of Maldives. Since January 2016, Mr. Sareer

has also been serving as Co-Chair of the Steering Committee on Partnerships for Small Island Developing States on behalf of the President of the United Nations General Assembly, constituted by the latter under UNGA resolution 70/202.

## **H.E. Mr. Frederick Musiiwa Makamure Shava**



H. E. Mr. Frederick Musiiwa Makamure Shava received his BSc in Biology from University of Zambia, and MSc/DIC in Nematology from Imperial College, and Mphil/PHD in Parasitology from Royal Holloway College. He worked as Minister of Labour, Manpower Planning and Development from 1981 to 1986; minister of State for Political Affairs from 1987 to 1989; Member of Parliament of Zimbabwe from 1980 to 2000; Consultant on Parliamentary Reforms for the Parliament of Zimbabwe from 2003 to 2004; Ambassador to the People's Republic of China from 2007 to 2014.

## **H.E. Ms. Dessima Williams**



**Ambassador Dessima Williams** serves as Special Adviser for Implementation of the Sustainable Development Goals. She brings experience as a diplomat and negotiator, a social development advocate, professor and private sector investor. In the 1980s, Ambassador Williams served as Grenada's representative to the Organization of American States, Deputy Governor to the World Bank and Deputy Permanent Representative to the Inter-American Commission of Women. At the Organization of American States, she shepherded resolutions such as the Caribbean as a Zone of Peace, Development and Independence and promotion of small island states.

Dessima has taught at secondary, college and university levels and is an advocate for the rights of women and girls, for farmers and for rural development. She founded the Grenada Education and Development Programme, which supports Grenada's students as emerging leaders. She has also owned a business in the tourism sector.

In 2009-2013, she was Ambassador Extraordinary and Plenipotentiary of Grenada to the United Nations, with three of those years concurrently as Chair of the Alliance of Small Island Developing States. In this capacity, she led a 40-island global climate change effort that recorded the high ambition of keeping average global temperatures to 1.5 degrees in the Copenhagen Accord of 2009, which was later included in the 2015 Paris Agreement. Dessima has participated in numerous sustainable development and political meetings, including Rio+20 and the first and third United Nations Conferences on Small Island Developing States.

## Dr. Mukhisa Kituyi



**Mukhisa Kituyi**, of Kenya, is UNCTAD Secretary-General since September 2013, has an extensive background as an elected official, an academic, and a holder of high government office. He also has wide-ranging experience in trade negotiations, and in African and broader international economics and diplomacy.

He studied political science and international relations at the University of Nairobi and at Makerere University in Kampala, Uganda, receiving a BA in 1982.

He went on to earn an MPhil in 1986 and a doctorate in 1989 from the University of Bergen, Norway. Dr. Kituyi served as a researcher at Norway's Christian Michelsen Institute from 1989 to 1991, and as Programme Director of the African Centre for Technology Studies in Nairobi from 1991 to 1992. He was elected to the Kenyan Parliament in 1992, and was twice re-elected. He was Kenya's Minister of Trade and Industry from 2002 to 2007. From 2008 to 2012, Dr. Kituyi was a member of a team of experts advising the presidents of the nations of the East African Community on how to establish more effective regional economic links. From 2011 to 2012, he was a consultant for the African Union Commission, where he helped to develop the structure for a pan-African free trade area. Prior to leading UNCTAD Dr. Kituyi was Chief Executive of the Kenya Institute of Governance, based in Nairobi, a think tank and advocacy organization that focuses on linking academic research and the development of public policy.

## Mr. Nikhil Seth



**Mr. Nikhil Seth** was appointed by the United Nations Secretary-General Ban Ki-moon as UN Assistant Secretary-General, Executive Director of the United Nations Institute for Training and Research on 8 June 2015.

Before assuming the post of the UNITAR Executive Director, Nikhil Seth was the Director of the Division for Sustainable Development, Department of Economic and Social Affairs (DESA) at the United Nations Secretariat in New York. In this role he served as head of the Rio+20 secretariat and of the secretariat for the Third International Conference

on Small Island Developing States, spearheading the preparations for these conferences in Rio, Brazil, and Apia, Samoa. He was also closely engaged in coordinating and advancing their follow-up. Mr. Seth's Division was also responsible for supporting the intergovernmental negotiations for the post-2015 development agenda, which was adopted at the United Nations Sustainable Development Summit 2015 in September 2015.

## Ms. Heidi Schroderus-Fox



**Heidi Schroderus-Fox** was appointed as Director of the United Nations Office of the High Representative for the Least Developed Countries, Landlocked Developing Countries and Small Island Developing States (UN-OHRLLS) on 3 July

2012. She serves as Deputy to the High Representative and oversees the management and the programmatic work of the office.

During 2010-2011 she served as Head of Policy Issues for the Office of the President of the United Nations General Assembly (OPGA), where she advised the President of the General Assembly (PGA) on all policy issues under consideration and led a group of policy experts. On behalf of the PGA, she developed ideas for thematic debates and helped to mediate complex negotiations, for instance, on the UN Peacebuilding Review. She also coordinated the preparations of the High Level Meeting on the Implementation of the Mauritius Strategy for the Sustainable Development of Small Island Developing States, as well as the OPGA preparations for the Fourth UN Conference on the Least Developed Countries.

Ms. Schroderus-Fox holds the rank of Ambassador in the Finnish Foreign Service, making significant contributions in the areas of inter-governmental policy dialogue, partnership building and negotiations. In 2006-2010, Ms. Schroderus-Fox served as Deputy Permanent Representative of Finland to the United Nations in New York. Prior to being posted to the UN, Ms. Schroderus-Fox held a succession of increasing leadership positions at the Finnish Foreign Ministry and in diplomatic postings to Paris, Washington DC, Tel Aviv, Geneva and Pretoria.

## **Reverend Dr. James Moultrie (Master of Ceremony)**



**Dr. James Moultrie** was born in Eleuthera in The Bahamas and is an ordained priest since 1994 in the Anglican/Episcopalian church. He is currently Associate priest at the historic St. Agnes Anglican Church in Nassau. His career spans forty-three years in the public service of The Bahamas Government variously as a senior public administrator, policy maker and diplomat. He has served at the most senior levels in the Ministry of Education as Director of Youth and Community Services;

Ministry of Foreign Affairs and the Ministry of Youth, Sports and Community Development.

In 1980 Dr. Moultrie was elected to the House of Assembly as the Member of Parliament for the constituency of Rock Sound, Eleuthera, where he remained an MP until 1992. In 1987 to 1993, Dr. Moultrie served as the Ambassador Extraordinary and Plenipotentiary at The Bahamas Mission to the United Nations. From 2004 to present Dr. Moultrie has continued to lead and provide direction on public administration in The Bahamas, serving variously as a Member of the Public Service Commission, Member of the Judicial and Legal Services Commission; Chairman of The National Insurance Board. In 2013 he was appointed as Chairman of the Public Service Commission.

Dr. Moultrie holds a B.Sc in Sociology from the University of the West Indies, Jamaica; a M.Ed in Administration from the University of Miami, Fla., USA and a Ph.D in Sociology from Columbus University, New Orleans, Louisiana, USA. In addition, Dr. Moultrie holds a Dip. Th from the General Theological Seminary in New York, USA.

### H.E. Mr. Oliver Joseph



**Ambassador Oliver Joseph** joined the Grenada Public Service in 1982. He was elected a Member of Parliament on the 19th February, 2013. He holds the portfolios of Minister for Economic Development, Planning, Trade & Labour. He served in various positions including Director of Trade in 1999 and Permanent Secretary, Ministry of Foreign Affairs from August 2006 to 2009.

He was an adjunct Lecturer in Economics at the T.A Marryshow Community College and Tutor at the University of the West-Indies Open Campus (2003-2008).

On the 1st of November 2009 he was seconded to the Caribbean Centre for Development Administration (CARICAD) as Integration Specialist.

Mr. Joseph holds a Bachelor's Degree in Economics and Management, Diploma in Trade Policy and a Master's Degree in International Trade. He has also received specialized training in Trade Negotiations. He brings a wealth of experience in the field of Public Policy.

### Hon Hazel Brandy-Williams



**Hazel Brandy-Williams**, Minister Nevis island administration. She was born in 1967, and citizen of St. Christopher and Nevis. She received her BA in Finance at University of the Virgin Islands BA, and her MSC in Risk Management & Financial Services at University of Glasgow. Currently she is studying at University of London LLB.

She joined Nevis Island Administration in 1988; worked at Deputy Comptroller Inland Revenue from 1998 to 2000. Then she worked as Budget Analyst from 2000 to 2002 and Budget Director from 2002 to 2007, later she worked as Registrar of International Insurance from 2007 to 2013, then became Junior Minister of Social Development from 2013 until now. She worked closely with Minister with responsibility for the Ministries of Social Development, Youth, Sports, Community Development, Basic Needs Trust Fund (BNTF) Unit and Sustainable Human Development, and affiliated with the Concerned Citizens Movement Political Party.

### H.E. Mr. Elisaia Ali'ioaiga Feturi



**Ambassador Ali'ioaiga Feturi Elisaia** is Samoa's Permanent Representative to the United Nations, and is concurrently Ambassador to the United States of America and High Commissioner to Canada, posts he has held since September 2003. He was Assistant Chief Executive



Officer, Corporate and Support Services in Samoa's Ministry of Foreign Affairs and Trade for three years prior to his current appointment.

He was seconded from Samoa's Public Service to serve as Co-Director of the Samoa Office of the Hanns Seidel Foundation, a German Political Foundation for 13 years (March 1988 - March 2001). He also served as Deputy Secretary for Samoa's Foreign Affairs for over 3 years (December 1984 - February 1988). He served as First Secretary at Samoa's High Commission to New Zealand for three years from 1991 to 1994.

During his current posting, Ambassador Elisaia has served in the following capacities:

- Chairman of the Pacific Islands Forum Group in New York (2004-2005);
- Representative of the Small Island Developing States (SIDS) on the Bureau of the United Nations Framework Convention on Climate Change (UNFCCC) from 2007 to 2008;
- Samoa's Political Focal Point to the Global Environment Facility (GEF) since 2006;
- one of the two representatives of Small Island Developing States [SIDS] on the Transitional Committee that designed the Green Climate Fund (GCF) in 2011;
- Alternate Member for SIDS on the Board of the Green Climate Fund from 2012-2015, and
- Current SIDS representative on the Board of the GCF from 2016 to 2018

Ambassador Elisaia has represented his country in numerous major global conferences and High-level events during his more than a decade years as his country's envoy to the United Nations.

## Ms. Grete Faremo



**Ms. Grete Faremo** joined UNOPS as Executive Director in August 2014.

Before this appointment, Ms. Faremo held various senior-level positions for the Government of Norway. Most recently, she was Minister of Justice and Public Security; a role she held for two years. During her first appointment as Minister of Justice, Ms. Faremo initiated negotiations between Schengen member countries and Norway on security and free movement in Europe, which culminated in the Nordic Schengen Agreement, signed in 1996 by the Governments of Denmark, Finland, Iceland, Norway and Sweden. She was Minister of Defence (2009-2011), Minister of Oil and Energy (1996),

Minister of Justice (1992-1996), and Minister of Development Cooperation (1990-1992) for the Norwegian Government's Ministry of Foreign Affairs. She was elected member of Parliament from 1993 to 1997.

Ms. Faremo also brings a wealth of experience from the private sector, working as the Executive Vice President for the Norwegian insurance group, Storebrand, from 1997 to 2003. From 2003 to 2008, she held the position of Director of Law and Corporate Affairs at Microsoft Corporation's Western European Office, where she developed the legal and public affairs division responsible for corporate compliance in the region.

Ms. Faremo graduated from the University of Oslo in 1978, with a degree in Law, specializing in International law. She entered the public service in 1979, as an executive officer in the Norwegian Government's Ministry of Finance, later moving to NORAD in 1980, and the then newly established

Ministry of Development Cooperation, where she worked for six years. She is quadrilingual, fluent in English, Danish and Swedish, aside from her Norwegian mother tongue.

## Ms. Elina Palm



**Ms. Elina Palm** is currently the Acting Head of the New York Liaison Office of the UN Office for Disaster Risk Reduction (UNISDR). She has 19 years of experience from various positions with the UN system, both from the headquarters and from the field in the areas of disaster risk reduction, sustainable development and climate change. From July 2005 to December 2006, she worked for the Office of the Special Envoy for Indian Ocean Tsunami Recovery, with focus on early warning and disaster risk reduction.

Prior to her assignment in New York, she was the Head of the UNISDR Regional Office for Latin America and the Caribbean, based in San José in Costa Rica (2001-2005). Prior to joining the United Nations, Ms. Palm has worked with the Finnish government, international NGOs as well as with local authorities in Karnataka, southern India. Ms. Palm holds an MSc in Development Studies from the Graduate Institute of International and Development Studies of University of Geneva, Switzerland.

## Ms. Rubyna Boodhoo (Group Rapporteur)



Since June 2015, **Rubyna Dyal-Boodhoo** is a Lead Analyst with the Strategic Policy and Planning Department at the Prime Minister's Office, which is responsible for advising Government on strategic planning and issues of national interest. She has contributed actively to the preparation of Vision 2030 Blueprint which has as objective to move Mauritius to a high-income, sustainable and inclusive economy by 2030.

Rubyna has a diverse range of experience gained from working for more than 20 years as an economist and financial analyst with the Ministry of Finance and Economic Development. She has led several teams on planning and public finance, and on policy and project elaboration in a wide range of sectors, including education, health, poverty, housing, gender, small and medium enterprises, regional trade and investment, food security, and environment and disaster management.

From June 2013 to December 2014, she worked with the "Maurice Ile Durable Commission, under the aegis of the Prime Minister's Office to implement the "Maurice Ile Durable Policy, Strategy and Action Plan".

## H.E. Ms. Malgorzata Wasilewska



**Malgorzata Wasilewska** took up her post as Ambassador/Head of Delegation at the Delegation of the European Union to Jamaica, Belize, The Bahamas, Turks and Caicos Islands and Cayman Islands on September 1, 2016. Previously, she was Head of Division for Conflict Prevention, Peace Building and Mediation at the Security Policy Directorate of the European External Action Service (EEAS) in Brussels. In this capacity, she led a team responsible for focusing EU's work on conflict prevention and peacebuilding, providing mediation support to EUSRs and Delegations, running the EU's Early Warning System for

violent Conflict and developing a new framework for EU's support to Security Sector Reform. In this role her team has provided support to EU Delegations in: Syria, Colombia, Mali, Myanmar, Lebanon, South Sudan, Tanzania, Kenya, Mauritania, Nigeria, Burundi, Central African Republic, Guatemala, Great Lakes/DRC, Moldova, Bosnia Herzegovina, Guinea Bissau, Chad, Afghanistan, Kirgizstan and Tajikistan.

Previously, she was Head of Division for Elections and Democracy Support in EEAS and prior to that at the Directorate General for External Relations of the European Commission. She has managed Electoral Observation Missions of the EU to DRC, Tunisia, Nicaragua, Peru, Zambia, Southern Sudan (referendum for independence and elections), Uganda, Niger, Chad, Mozambique, Honduras, Bolivia, Togo, Ethiopia, Burundi, Solomon Islands, Guinea Conakry, Afghanistan, Rwanda, Tanzania, Ivory Coast, Sudan (elections and referendum).

Before joining the European Union, Ms Wasilewska worked as a senior specialist on issues of organizational governance and strategic planning at Amnesty International and Saferworld, both at the national and global level. Her main areas of specialization were organizational transition and growth, human rights, conflict sensitive development, post-conflict democracy building and non-proliferation of small arms and light weapons.

## Ms. Ebba Dohlman



**Ebba Dohlman** is Senior Advisor in the OECD Office of the Secretary General and Head of the Policy Coherence for Development (PCD) Unit, currently developing guidance and tools to enhance policy coherence for sustainable development as a key means of SDG implementation. She has worked at the OECD since 1985 in various functions, including to support the Deputy Secretary-General in charge of development to help shape and take forward the OECD Strategy on Development; as Senior Counsellor in the Heiligendamm L'Aquila Process (HAP) Support Unit where she was responsible for the development and energy

pillars of the dialogue between the G8 and G5; and as policy analyst in the Trade and Development Co-operation Directorates providing key inputs into the work on Trade, Environment and Development, Aid for Trade and Pro-Poor Growth and Agriculture. Prior to this, she worked as a

### **Dr. Louis Meuleman (*Moderator*)**



**Dr. Louis Meuleman** is advisor, manager and trainer on (sustainability) governance and metagovernance, public administration reform and sustainability transitions. He has an MSc in environmental biology and a Phd in public administration and is visiting professor at the Public Governance Institute of the University of Leuven (Belgium), senior fellow at the Center for Governance and Sustainability of the University of Massachusetts Boston (USA) and research associate at the Public Administration & Policy Group of Wageningen University & Research (Netherlands). His experience as public manager at subnational, national and European level covers 30 years. In addition, he publishes on topical governance challenges and has presented or moderated at various UN conferences, including the 2016 HLPF.

Louis is a Dutch national who lives in Brussels, Belgium. He works as coordinator Environmental Implementation Review at the European Commission but attends this symposium in personal capacity.

## Mr. Uchita de Zoysa



**Uchita de Zoysa** is an internationally acclaimed sustainability thinker, writer, speaker and currently serves as the cabinet appointed Sustainable Development Advisor to the first ever Ministry of Sustainable Development and Wildlife in Sri Lanka. In this capacity, he is leading the country process of designing the National SDG Implementation mechanism. He was Sri Lanka's Chief Negotiator at the UN Asia Pacific Forum on Sustainable Development (APFSD) in Bangkok and UN High Level Political Forum on Sustainable Development (HLPF) in New York in 2016. He has been closely involved in the international sustainability negotiations from the 1st Earth Summit in 1992, though WSSD in 2002 and Rio+20 in 2012. He is also the Chairman of Global Sustainability Solutions and Executive Director of the Centre for Environment and Development.

He is the author of several books including the "It has to be CLIMATE SUSTAINABILITY" and has authored several international reports including the 'Asian Review on Sustainable Consumption', contributed to many books on the environment and sustainability, and has played a leading role in the formulation of global independent sector collective agreements such as the 'The NGO Alternative Treaties', the "Oslo Declaration on Sustainable Consumption" and the "Peoples Sustainability Manifesto". In 1991 he created and lead the then largest environment & development NGO coalition in Sri Lanka called the "Public Campaign on Environment & Development" and edited the country's first ever "Citizens' Report on Environment & Development".

Mr. de Zoysa has travelled widely across the world participating in the largest UN world summits and has presented papers for several hundred conferences as a strong advocate of sustainability. He has managed various project teams on sustainable development, climate change, green skills and education, corporate social responsibility. Born in Rio de Janeiro-Brazil, he now lives in Sri Lanka, working towards creating a sustainable world!

## Ms. Marion Barthélemy



**Ms. Marion Barthélemy** is the Director of the Division for Public Administration and Development Management of the United Nations Department of Economic and Social Affairs. Before joining the Division, she was Chief of the Intergovernmental Support Branch at the United Nations Division for Sustainable Development, Department of Economic and Social Affairs (DESA). In this capacity, she was part of the team supporting the negotiations on Agenda 2030. From 2007 to 2012 she served as Chief of the Development Cooperation Policy Branch of the Office for Economic and Social Council Support (DESA), supporting the Development Cooperation Forum and the General Assembly's review of UN

system country-level activities (QCPR). From 2000 to 2005, she served in the Office of two Under-Secretary-Generals for Economic and Social Affairs, supported the Assistant Secretary-General for Policy Coordination and served as Special Assistant to the UN Deputy Secretary-General. At the beginning of her career, she worked as an economist in the Division for the Advancement of Women and later in the UN Drug Control Programme with the Secretary of the International Narcotics Board. She joined the UN in 1987 through the National Competitive Exam for economists and studied in “Sciences Po” Paris (with a focus on macroeconomic and social policies).

## Mr. Raymond Saner



**Raymond Saner** is co-founder of CSEND, a Geneva based NGRDO (non-governmental research and development organization, 1993-present), an ECOSOC accredited organization with special consultative status- and director of its Branch DiplomacyDialogue.

He is Titular Professor at Basle University (Economics Department) , Sciences Po, Paris (Policy Analysis) and Lüneburg University (Environmental Negotiations) and has published and researched on Inter-ministerial Policy Coordination and Consultation, Public Administrative Reform and Institution Building, Training Effectiveness and SDG Monitoring and Negotiations

It may be consulted by the government on any draft legislation or regulation in the digital field.

An engineer by training, Yann Bonnet began his career as a consultant. He joined the French Digital Council in March 2013 as General Rapporteur, before becoming Secretary General in June 2015. He was in charge of steering the national consultation on societal and economic issues related to digital transformations, which was launched by the Prime Minister in October 2014. This initiative aimed to fuel the construction of the French digital strategy and it resulted in the "Digital Republic Bill" that was promulgated into law in October 2016. Yann Bonnet was also in charge of drafting multiple

### H. E. Mr. Aroldo Cedraz de Oliveira



**Aroldo Cedraz**- Minister, Federal Court of Accounts of Brazil. Aroldo Cedraz was a Congressman from 1991 to 2007, with special focus on issues related to education, science, technology, defense and foreign affairs. He was the author of the National Water Resources Policy, and President of the Congressional Commission for National Defense and Foreign Affairs from 2005-2006. Besides, he was Secretary of State in Bahia on two occasions and President of Ford Executive Group in Brazil. Since 2007, he is a licensed professor at the Federal University of Bahia and Minister at the Federal Court of Accounts of Brazil (TCU).

Cedraz was the President of TCU for 2015-2016, and during this period dedicated himself to foster the digital transformation of TCU and of the entire Federal Public Administration, through the intensive use of data analytics, information technology and innovative practices. These initiatives were supported by the creation of an innovation lab inside TCU (coLAB-i) and by massive investments in the Court's corporate university, Serzedello Correa Institute. The ideas and activities that renovated are described in the book "Control of Public Administration in the Digital Age", co-written by Cedraz and several TCU auditors. As Minister of the Federal Court of Accounts, Cedraz remains committed to promoting the adoption, by the public sector, of policies and practices that may lead to the goal of turning Brazil, as well as other fellow countries, into a 100% Digital Nation.

### Mrs. Pamela Monroe Ellis



**Mrs. Pamela Monroe Ellis** was appointed Auditor General in 2008 having spent the early part of her career at PricewaterhouseCoopers. A Fellow of the Institute of Chartered Accountants of Jamaica (ICAJ) and the Association of Chartered Certified Accountants (ACCA, UK) Mrs. Monroe Ellis sits as Chair of the ICAJ's Investigations Committee. She is also a member of the Commission for the Prevention of Corruption Board and the Integrity Commission of Jamaica.

As Auditor General of Jamaica, Mrs. Monroe Ellis is a member of the Caribbean Organization of Supreme Audit Institutions (CAROSAI), and was appointed Secretary General in June 2016. In 2012, Mrs. Monroe-Ellis was elected to the Board of the International Federation of Accountants (IFAC) and was recently appointed to Chair its Governance Committee. She is Jamaica's representative on the CARICOM Secretariat Audit Committee, which she also Chairs.

## Mr. Paul G. Larsen



**Paul Gulleik Larsen** is a Norwegian MFA diplomat with 26 years of international and United Nations experience, including postings in Belgrade, Moscow and New York. He served two years as diplomatic advisor in the Office of the Prime Minister of Norway. During six years as Chief of Staff and Director at the UN World Food Programme (WFP) in Rome, he represented WFP as “Sherpa” in G20/G8 food security/development groups and in high-level UN coordination bodies (CEB, UNDG, HLCP, IASC), and sat in WFP Committees for audit and investment.
